Booth and setup information:

ALL VENDORS MUST FURNISH ALL ITEMS NEEDED FOR THEIR BOOTHS, i.e., tent, tables, chairs, display racks, etc. Booths will be 12x12. All tents must be 10 x 10 white tents and must have at least ten pounds of weight on each leg. Artists are expected to keep their booth space tidy and be courteous to artists around them. Booth space is assigned by the arts festival committee on a first-come, first paid basis as artists are juried into the show.

Vendors will have an assigned location for parking and will be instructed to move their vehicles to that location after unloading their vehicle and before setting up their booth. FESTIVAL COMMITTEE RESERVES THE RIGHT TO MAKE BOOTH ASSIGNMENTS and to REFUSE ACCEPTANCE OF ANY APPLICANT.

Set-up is Friday September 14th from 4 pm to 8 pm and Saturday September 15th, from 7:30am to 9:30am. Further set up instructions and information will be sent to artists juried into the show. Booths must be ready by 10:00 am on September 15th, at which time the Artists' Brunch starts. Tear down begins at 6 pm on September 15, 2018.

DO NOT MAIL BOOTH CHECKS UNTIL YOU RECEIVE YOUR JURY STATUS AND INVITATION TO EXHIBIT. The jury process will be ongoing as applications are received and the turnaround time is often very short. Booth Payments will be due in full two weeks after notification of acceptance. There will be a \$30 fee for returned checks. Artists are responsible for obtaining all necessary business licenses and sales tax permits, if required by State Law.
